General

WiseOne AB is a Swedish limited company located in Isafjordsgatan 32C, 164 40 KISTA. This document contains information about our consultant agency web site (www.dataconsultants.info), our policy regulating the usage of the information provided on the site and our strategies related to the processing of personal data.

By visiting our web site and using its services you consent to the policies stated in this document. You also grant the permission to WiseOne AB to process your personal data in accordance with the General Data Protection Regulation (GDPR), (EU) 2016/679.

When do we process your personal data?

Your personal data is subject to processing by WiseOne AB when you register a consultant/customer account on our consultant agency web site (www.dataconsultants.info), and when you perform one of the following actions on this account: create a profile, register for our assignment or consultant subscription service, apply for an assignment, in any other way try to get in touch with us.

What kind of personal data do we record?

The account creation process involves database recording of the company name, address and organization number as well as the name, phone number and email address of the company representative.

The profile creation process involves database recording of the following profile data: name, email address, marital status (optional), birth year and a survey of competences.

WiseOne does not collect any kind of sensitive information. If ,on the other hand, you yourself choose to publish such information on our web site, you are considered to have given your consent to the recording of the data.

Why do we process your personal data?

As soon as you register an account on our web site - or let us do it for you - you become one of our clients. This means your personal registration data is stored in our database for later use. If you are selected for an assignment by a customer your personal data is requested for administrative and billing purposes.

Your personal data may also be used in the monitoring and development of the services offered by WiseOne. When you apply for assignments, send in requests to work with us, take part in surveys or simply wish to be contacted by us, we will use your personal data as appropriate in each case.

We may use your personal data for marketing purposes, in which case you will get emails from us. You can turn this functionality off at any time simply by clicking a link in the email message or by contacting us at info@dataconsultants.info or phone 08-6731480.

With whom do we share your personal data?

When you apply for assignments published on our web site and your application is selected for offer submission, your personal data will be sent to the assignment owner along with your application. By submitting your application you grant the permission to WiseOne to include your personal data in an offer submission to the assignment owner.

As far as the monitoring and development of the services offered by WiseOne is concerned your personal data may be exposed to our business partners. Other than this no personal data is revealed to anyone outside WiseOne unless clearly stated when collecting the data or otherwise prescribed by law.

How long do we store your pesonal data?

We store your personal data as long as it is needed for us to be able to fulfil our obligations towards our customers in terms of service providing and billing.

If you have had an assignment at a customer administered by WiseOne your data will be stored for seven years from the assignment start date. This is according to the Swedish Bookkeeping Act. In all other cases we store your data as long as you want to. You can remove it yourself or let us do it for you.

What are your rights?

You are entitled to know exactly which of your personal data is subject to processing by WiseOne. In case you want such information you have to hand in a written request (see below for contact information). The same applies if you consider some data to be incorrect or misleading and want to have it changed.
